#### Grandma Jessie's Rhubarb Custard

- 3 Cups Rhubarb, diced
- 12 soda crackers (aka Saltines), crushed
- 1 1/4 Cup Sugar
- 3 Tbsp butter, melted
- 3 Eggs, beaten
- Cinnamon
- 1. Pre-heat oven to 375° and lightly grease/spray an 8x8 pan.
- 2. Combine all ingredients thoroughly, except cinnamon
- 3. Sprinkle cinnamon on top.
- 4. Bake for 50-60 minutes, until knife comes out clean.
